AFFIDAVIT

The undersigned, of lawful age, being first duly sworn, upon oath deposes and states as follows:

1. That he is an Investigator with the Oklahoma State Board of Veterinary Medical Examiners.
2. That this event occurred within the County of Tulsa and State of Oklahoma.
3. That he has made personal observations, read certain official investigative reports and statements of witnesses regarding the above named Defendant and, from these observations, statements and reports, it appears as follows:
